



Clean Currents Exhibitor FAQs

What is included in your booth?

Each 10' x 10' booth will be set with 8' high blue and white back drape and 3' high blue side dividers. Booths 300 sq ft or less will receive a 7" X 44" one-line identification sign. Booths larger than 300 sqft may receive a 7" X 44" one-line identification sign upon request.

Are there any booth restrictions?

- o *Island Booths*: Island booths are booths exposed to aisles on all four sides, with a minimum size of 20x20. The maximum height of an island booth is 20' when ceiling height and rigging permit (20' from the floor to the top of any booth components and signs). No signage, lighting fixtures, or light/sign trusses are allowed outside the boundaries of the exhibit space.
- Linear Booths: Linear booths may not exceed eight feet (8') in height. Display materials should be arranged in such a manner so as not to obstruct sight lines of neighboring exhibitors. The maximum height of eight feet is only allowed in the rear half of the booth space, with a four-foot (4') height restriction imposed on all materials in the remaining space forward to the aisle.

Allotments

- For EVERY 10' x 10' booth (100 square feet) purchased, an exhibitor receives 2 complimentary registrations. These registrations include the following (estimated value of \$1,800):

What is an Exhibitor Appointed Contractor(EAC)?

o If an individual exhibitor chooses to utilize its own contractor ("EAC") to provide any of the non-exclusive services that the Official Service Contractor may otherwise perform, you must provide a written statement (Intent to use Non-Official Contractor form) and provide a certificate of insurance evidencing that the EAC has in place the minimum insurance coverage as defined in the Terms and Conditions and in compliance with all city, county, local, state, and federal laws.

Is there Lead Retrieval?

- Essentially, we are not offering lead retrieval this year after we consulted with our Exhibitor Advisory
 Committee in review of last year's Clean Currents. Here are a few reasons:
 - Renting the device from our vendor was expensive and required exhibitors to work with "yet another vendor." So, it seemed too much like "nickel and diming," which we absolutely want to avoid
 - We've learned that many exhibitors already have a system they use
 - the review of who actually rented the devices at CC 2021, we learned it was around ~10% of exhibitors. Exhibitor responses in the post-event survey were mixed.

So, we decided on offering attendee lists as part of the exhibitor package, sent 4 weeks prior to Clean Currents. NHA members receive attendee contact information as a benefit of their membership, too.

Where can I upload my company logo and contact info?

Why is my logo not uploading?

• You must upload a .eps or .al file type. This ensures that your logo is of the highest quality when printed or presented online.
